Pursuant to both the Federal Fair Credit Reporting Act ("Federal-FCRA"), 15 U.S.C. §1681 *et seq.*, and the New Jersey Fair Credit Reporting Act ("NJ-FCRA"), N.J.S.A. 56:11-28 *et seq.* (collectively "FCRAs"), the Hebrew Academy of Morris County (the "HAMC") HEREBY NOTIFIES YOU OF THE FOLLOWING:

In order to consider you for service as a volunteer at the Hebrew Academy of Morris County (HAMC), the HAMC may request that you authorize and direct the HAMC to obtain a consumer report that may include information regarding your criminal history, motor vehicle and driver's license history, character, general reputation, credit, job performance, personal characteristics and mode of living. Any consumer report so obtained will be used only for purposes of evaluating you for volunteer service at the HAMC.

If the HAMC intends to take any adverse action based in whole or in part on the consumer report, you have the right to be notified of the HAMC's intention and to obtain a copy of the consumer report before the HAMC takes that action. You also have the right to dispute the accuracy of any information in the report by contacting the consumer reporting agency, ChoicePoint, 1000 Alderman Dr. Alpharetta, GA 30005, 800-845-6004.
